Principles

Legal Compliance

Suppliers must always act in compliance with all applicable laws and regulations, adhering to both local and international standards. When local laws are stricter or provide greater protections than the Code's requirements, suppliers must adhere to those provisions. This principle ensures that suppliers' business practices align with the highest legal standards, fostering responsible behavior in every context.

Human Rights and Working Conditions

Suppliers must commit to respecting human rights and promoting a dignified work environment for all employees. This includes preventing and eliminating practices such as child labor or forced labor in all its forms. Any use of physical force, abusive disciplinary practices, or involvement in human trafficking is strictly prohibited.

Suppliers must also respect employees' rights to freedom of association and, where provided by law or the social system, support collective bargaining. Diversity and inclusion are values that suppliers must embrace, ensuring an environment free from discrimination based on gender, ethnicity, religion, age, sexual orientation, marital status, disability, or any other personal characteristic.

The well-being and safety of workers are priorities; suppliers must ensure safe and healthy working environments, comply with regulations, and provide fair working conditions, including remuneration in accordance with applicable laws.

Every partnership must be based on values of trust, transparency, and mutual cooperation. Suppliers are required to promptly inform the company of any circumstances, in their operations or those of their subcontractors, that conflict with the principles outlined in this document.
